- Students who qualify for supplementary examinations and have G20 block in their portal must complete the appeal form prior writing their supplementary examinations.
- Students must scan their appeal form together with their supporting documents as a SINGLE ATTACHMENT in a PDF Format and send it via e-mail to: <u>G20Appeals@mut.ac.za</u>. Please be advised that separate documents sent via e-mail will not be processed.
- G20 appeal forms received after the closing date will **NOT** be considered.
- Students must attach all the necessary supporting documents.
- Incomplete G20 appeal forms and/or without the necessary supporting documents will **NOT** be considered.
- The appeal form is **NOT** applicable to R22 block.
- Results of G20 appeals will be available on student portal iEnabler after the seating of the appeals committees.
- Closing date for emailing of G20 forms is Thursday, 04 July 2024.
