WHAT IS THE MUT LOOKING FOR

BACKGROUND

Mangosuthu University of Technology (MUT) seeks to engage in a competitive process for the appointment of a service provider for a Managed Service Online Security Awareness Platform as specified hereunder.

High Level Overview of the Services Required

The Managed Service Online Security Awareness Platform must provide:

- Cyber/Information Security eLearning
- Policy Management
- Phish Simulation
- Management & Automation
- Technology Requirements & Support

Specification:

Information Security eLearning

The Custodian 360 Online Security Awareness Platform must provide cyber/information security eLearning, that can be personalised for different groups and job roles across MUT. The eLearning must include access to multiple pre prepared videos and other content that are current and can be tailored to MUT. The eLearning platform will be used for user induction training to ensure that everyone is trained in information security from the start.

The vendor must ensure that the training material is continuously updated to reflect new and growing threats, rather than MUT having to create the content.

Policy Management

The Custodian 360 platform must include centralised policy management, which will allow us to manage our information security policies, perform staff knowledge assessments, and have access to full compliance reporting for auditing purposes.

The platform must allow us to obtain and record policy acceptance and quanitfy staff understanding of policies.

Phish Simulation

MUT requries Vendor Led Simulated Phishing Campaign creation under the advice of the MUT IT&N Staff. Any new created campaigns will be signed off by MUT IT&N or within the guidelines set out in initial engagements. There will be no limit to the number of campaigns created as well as the number of simulations that are rolled out. The Custodian 360 platform must also include phishing simulation capability and must allow us to automate regular phish simulation to gauge user awareness around different types of phishing attacks as well as gauging the effectiveness of our user training. The platform must include multiple customisable templates that can be targeted to specific sets of users. The platform must include detailed compliance reporting to show us detail on who failed the phish simulation and who failed to complete the allocated training.

Management & Automation

To simplify the management of the various elements of the platform, it must allow us to plan our yearly awareness campaigns in advance and fully automate security awareness training, phishing simulation and policy management.

The Custodian 360 platform must provide full compliance reporting so we can gain full visibility of the awareness program across the Agency.

Technology Requirements & Support

Custodian 360 is a web based solution, with minimal work required to implement. The platform is compatible with Microsoft Edge and Chrome which are used by MUT. There will be a requirement for single-sign-on using MUT credentials and so the system must integrate with our existing authentication systems via Azure AD.

The platform must be capable of sending emails to MUT users without requiring connection to MUT email systems to send the emails, i.e. emails should come from the platform and not from the MUT domain (MUT.ie).

The platform solution must be highly available and the bidder will be responsible for resiliency and disaster recovery of the solution. The solution must be fully compliant with POPIA.

MUT requires support during core working hours which are Monday – Thursday, 8:00am to 4:00pm, Fridays, 08:00 to 13:00pm, and should be fully outlined in the rfq response, including SLA/Response times.

Duration of the Contract

The Managed Service Contract will be for a maximum period of 12 months.

Once procured, the system will be implemented and configured for use for 700 users (University Staff).

Account Management

The University requires bidders to nominate a dedicated contract manager who will act as the main point of contact between MUT and the service provider for the duration of the contract. This person shall have the authority to deal with all matters in relation to contracts and be responsible for the satisfactory delivery of the supplies/services required. The duties of the contract manager will include the following:

- Overall responsibility for a good working relationship with the MUT IT&N
- Provide regular reports on performance as agreed with MUT IT&N

- Meet as and when required to review and examine performance
- Proactively discuss with MUT IT&N ways of improving efficiency regarding service delivery in general and providing suggestions for improvement and cost savings

NOTE: Bidders will note that account management activities will be non-billable (i.e. MUT will not pay separately for account management activities). MUT IT&N will nominate authorised staff to liaise with the successful bidder and delegate as required.
