Mangosuthu University of Technology (MUT) invite proposals for the provision and supply of academic attire for graduation ceremonies at Mangosuthu University of Technology.

PROPOSAL DESCRIPTION

1. Background

In December 2019 MUT launched a new Corporate Identity and in line with the University's new look and feel we seek the services of a reputable supplier of academic attire to submit proposed designs of graduate academic attire in line with MUT's qualifications. Through this request for proposals, the University seeks to appoint a preferred supplier of academic attire for MUT graduates. The designs and attire must adhere to University's corporate colour, faculty specific colours and differentiated qualification levels.

2. Eligibility criteria

- 2.1 Applicants must have a proven track record in the design and supply of academic attire;
- 2.2 Must be innovative and provide the designs that align to the MUT look and feel in accordance to the MUT's Corporate Identity Manual available from www.mut.ac.za/publications
- 2.3 Have sufficient resources to manufacture and supply the required sizes, correct colours, and quantities required for all graduation ceremonies.
- 2.4 Must have resources and personnel to serve graduates on-campus prior and on the date of each ceremony throughout the University's graduations.
- 2.5 Must have a system for online administration of orders, payments and coordination of the graduation supply process to the more than 3 000 graduates annually.



- 2.6 Have fully trained staff to attend to queries and sufficient stock to meet demands including emergency last minute orders and requests.
- 2.7 Provide convenient address in Durban (20 km radius) for graduates who wish to collect at the supplier's premises.

3. Nature of the request for proposals

The RFP does not create an obligation for MUT to purchase services from the applicant / service provider or to appoint an applicant to the University. This RFP will be subject to successful signing of a written contract failing which the University reserves the right to withdraw the contract. The successful service provider will the appointed on terms and conditions determined by MUT and acceptable to both parties.

4. Supplier / Applicant obligations

- 4.1 Eligibility
 - 4.1.1 Application documents to this RFP to be accompanied by proposed designs, garment samples or information for in line with each of the MUT qualification levels and faculties.
 - 4.1.2 Applicants must provide documentary evidence to proof their expertise and competencies in providing same or similar service.
 - 4.1.3 MUT will visit the site of shortlisted service providers on a date and time determined by MUT and agreed upon by both parties.
 - 4.1.4 The applicant is welcome to undertake site inspection of the MUT graduation venues to acquaint themselves with access route and nature of the spaces provided to them to as a service provider to the graduates.
 - 4.1.5 Information submitted in response to this FRP is accepted as being true and accurate. False declaration, misrepresentation or omissions may disqualify the applicant.

5. Pricing schedule

- 5.1 Applicants must complete the attached pricing schedule indicating their rates for both hiring and purchase of various items.
- 5.2 The pricing offered must take into account price fluctuations and escalations, the price offered to be fixed.

6. Insurance and liability

The successful applicant shall take insurance coverage in respect of all claims made arising from the rendering of services, damage to property or premises on campus where the services will be rendered.

7. Contract period

The contract with the successful applicant shall run from date of appointment for a period of three (3) years with the option to extend for a further two years, unless terminated by one of the parties as per agreement and terms of the contract.

8. Rights reservation

Mangosuthu University of Technology (MUT) reserves the right amend this RFP and the applicants shall comply with such amendment.

9. Scope of work

The scope of work included in this call for proposals include the following:


- 9.1 Provide academic attire for each qualification in line with the MUT Corporate Identity.
