### Introduction

Mangosuthu University of technology (MUT) wishes to contract a service provider to decommission and remove all access points, POE switches, attached cables from 20 buildings in Durban Central Business District. Decommissioning, uninstallation, and removal all UPS's and attached batteries. Isolate and or terminate all decommissioned devices from the Wi-Fi service at all the student residences. Transport the devices and equipment to main campus at Umlazi. Reinstall all AP's, supply cables, POE switches, UPS's and batteries at the main campus. Integrate all AP's and switches into the current campus WiFi network.

### Scope

The scope of this engagement is for a Service Provider to successful complete all deinstallation, decommissioning of devices, remove relevant equipment and devices, ensure the environment and building infrastructure is cleaned and all damage to walls, ceilings etc. is repaired.

- Uninstall 243 AP's and remove these switches attached to concrete walls and ceilings.
- Remove all cabling from network switches to AP's.
- Decommission and remove all switches from the cabinets of each floor or building.
- Uninstall UPS's and the batteries attached to the switches.
- Transport all of the decommissioned devices and equipment to the Umlazi Campus.
- Ensure all area's the devices and equipment was removed from is clean and damages to walls and ceilings repaired.
- Install all the functioning and compatible AP's at MUT.
- Install and integrate all the functioning and compatible POE switches removed from the student residences onto the campus.
- Supply and install all cabling to connect the switches and AP's integrated onto the current Wifi network.
- Test all installed AP's and integrated switches on the current network.
- Install and test working UPS's and batteries.
- Provide certified project manager and technical resources for successful completion of the project
