CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

Mangosuthu University of Technology (MUT) recently undertook a comprehensive internal and external penetration test to evaluate the security posture of its IT environment. The assessments revealed multiple critical vulnerabilities across the university's network, systems, and endpoints. These vulnerabilities pose significant security threats, including the potential for unauthorized access, data breaches, and service disruptions. With the increasing reliance on technology for academic, administrative, and research activities, these findings highlight the urgent need for immediate mitigation. Addressing these vulnerabilities is essential to safeguarding sensitive information, ensuring compliance with regulatory standards, and maintaining the operational integrity of the university's IT infrastructure.

2. Introduction

Mangosuthu University of Technology (MUT) invites qualified cybersecurity service providers to submit proposals including bids for the immediate remediation of its audit findings with the use of a patch management service. The patch tool should enable automated third-party patching, continuous monitoring, and effective remediation capabilities to mitigate risks in both internal and external systems.

3. Scope

For the purposes of this RFQ, MUT is unable to disclose sensitive information from the Penetration Test. We are however able to share the below to indicate the size of our environment:
