2. Background

The Mangosuthu University of Technology (MUT) has a shortage of office space for the academic staff at the Faculty of Natural Sciences, a resolution of demolishing the existing classroom facilities to erect a new double-story lightweight structure for additional office space, has been taken by the infrastructure department in consensus with the end-user department to accommodate staff members in need of offices.

3. Scope of Service

Assumed Loading

The anticipated new load-bearing brickwork and columns (service) loads are approximately 100, 200, kN vertical load and a linear load of 75, 100, 250 kN/m. Our maximum differential settlement must be limited to **10mm**. All loads will be confirmed once the service provider is appointed.

Geotechnical Investigation – Shallow Investigation: Minimum Requirements

Inter-alia, we require the following data to be presented in a detailed geotechnical report:

- Maximum net allowable bearing capacity of the in-situ soils. This will include possibility for light foundations e.g. generator rooms, single storey structures, lightly loaded retaining walls etc.
- Settlement/heave – differential and total.
- Comment on possible founding solutions. Including a ‘full’ detailed geotechnical design of the:
 - ‘ground improvement system’ or
 - ‘engineered fill’ required, if it forms part of your foundation recommendations in your Geotechnical Report.
- Comment on sub-soil/sub-grade conditions and general geology.
- Depth to groundwater table.
- Comment on excavation procedure of the in-situ soils – including advice in terms of excavating adjacent to existing R.C. and block retaining walls, where applicable.
- Material classification of in-situ soils and comment on the suitability of in-situ soils for usage on-site earthworks / layerworks.
- Comment on overall stability of the site including carrying out ‘slope stability’ analysis where applicable.
- All parameters / indices for the design of retaining walls.
- Soil permeability tests to assess on-site percolation.
- Allow for excavation of 2 no. off inspection pits for the geotechnical investigation.

The following laboratory tests are required, but not limited to the following:

- Foundation Indicator Tests. (Allow for 2 no. off).
 - Note: allow the above to be undertaken at approximately 3.0 meters below Natural Ground Level.
- Mod AASHTO Density Tests for the various soil types. (Allow for 2 no.)
- CBR Tests (allow for 2 no.)
- Swell potential tests (if clayey subsoils are encountered). (Allow for 2 no.)
- Standard Oedometer tests. (Allow for 2 no.)
- Triaxial tests (consolidated drained tests with pore water pressure measurements).
- UCS tests on rock/cement stabilized material samples (allow for 2 no.), If rock is encountered at shallow depths below existing ground level.

A map showing the proposed investigation points for both phase 1 and phase 2 investigations is seen below on figure 1. Only 2 investigation points are required for phase 2 only.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
