2. Background

Mangosuthu University of Technology is currently working on bringing its Strategic Plan to life by carrying out projects outlined in the approved Master Plan according to their priority. The Master Plan serves as a blueprint for the university's infrastructure development over time. Some of the projects identified in the Master Plan have been completed whilst some are still at different stages of the project lifecycle.

Currently, a project focused on the construction of new student residences, which will include 722 beds, requires the services of a surveyor to conduct a topographical survey of the site. Significant developments have occurred around the campus since the last survey was conducted over a decade ago. As the project is in Stage 2, the survey will be instrumental in assisting the Architect and Engineers with their designs moving forward.

Scope of Service

The following details are required but not limited to the scope of works described below:

- Survey to be based on WG31 and MSL of the area as shown on the attached locality site plan that is currently available. Note that the survey must include the full width of all adjacent road reserves and embankments (where applicable).
- The street addresses of all cadastral erven within the precinct must be indicated and including outside peripheral areas, together with the 'north' point.
- A digital terrain model must be taken at not more than 10m spacing to give a contour interval of 0.5m
- All site boundaries, fence lines, existing structures, streams/watercourses, solar panels, services, trees (trunk and crown) and all other features must be surveyed.
- All visible services must be investigated and measured giving invert level, cover level and pipe sizes of each manhole, including conservancy/septic tanks and associated plan dimensions/extents. Note that the surveyor has to include in his price for all manholes to be opened and surveyed.
- All street furniture, road markings, verge positions up to edge of road with all found services up to and including edge of road and levels on both top and bottom of kerbs must be provided.
- The survey must show the outline of all adjacent buildings. Note: where no adjacent buildings exist, the survey must extend at least 10m into the adjacent property.
- Cadastral data must be investigated and plotted showing all sub divisions and servitudes (including the existing servitudes). SG diagrams must also be made available to the Client.
- The 1:100 and 1:50 year floodlines of existing watercourses must also be shown (where applicable). Where streams/ watercourses do exist, the survey must extend at least 25m on either side of center line of said stream/ watercourse and the survey must also extend 500m upstream and downstream of the site boundary edges.
- Survey and plotting onto a drawing all water points (taps, valves, fire hydrants, stand pipes, boreholes, header tanks, water meters, etc.)
- All existing buildings (formal and informal) must be surveyed and clearly referenced on the overall survey site plan. A separate, more in-depth survey and plotting onto separate drawings will be required for all existing formal buildings. The following survey information will be required: Plan layout of each existing building indicating the corners of the building , the top of slab levels for all concrete surface beds, walkways, aprons, suspended slabs and concrete steps.
- Survey and plotting onto a drawing, existing Telkom services, cables, fiber optic cables, telephone poles, sleeves and telephone take-off points including : telephone manholes, sleeves, overhead/underground telephone cables and cellular masts.
- Survey and plotting onto a drawing, existing Transnet services, pipeline markers, pipe route, servitude and manholes. The surveyor is to include in his price to liaise directly with

Transnet to establish if any existing data is available for this precinct, collect the data and verify onsite and thereafter superimpose the data onto the final topographical survey.

- Survey and plotting onto a drawing all overhead power lines, overhead/ underground electrical cables, sleeves, light poles, electrical manholes, Mini-Subs and Sub-Stations.
- The surveyor to peg electrical and electronic cable routes (where applicable).
- The position and description of the closest bulk service 'take-off' point and route (sewer, water, stormwater, and electricity) must be indicated.
