The Executive Hotel in Umlazi was opened in August 1974 according to an article on IOL. "The imposing building high on a hill in W section, Umlazi, was owned by businessman and entrepreneur Thalente Goqo." The Executive Hotel in Umlazi today is being used as a residence for the Mangosuthu University of Technology. This must be verified against statutory documents to be sourced by the client appointed Town-planner. Currently, MUT Executive Hotel student residence is not in a good state for occupation by students. During Quarter 1 (Q1) of 2022, all students had to be vacated as it was deemed unsafe for occupation.

### **CERTIFICATE OF INDEPENDENT BID DETERMINATION**
