CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

Appointment of a suitable service provider for Sewer extraction(removal) and disposal from conservancy tank services.

Specification:

Sewer extraction a **56m³ (56 000L)** conservancy tank once a week (Every 4th day) or when required by MUT.

NB: (item 1 and2)

- Every 4th Day MUT representative to verify with the contractor the actual quantities (Litres of sewage extracted). The amount to be involved will be based on sewage extracted.
- The unit rate for travelling to be applicable in line with the actual kilometres travelled.

NOTE:

- Sewer extraction will be performed from MUT New Engineering Building.
- An additional conservancy tank with the estimated capacity of **67,5m³** at the New Student Centre Building will be included in the scope and rates quoted will be applicable.
- The successful bidder shall prepare and submit a safety file with all relevant documentation.
- The successful bidder will sign section 37(2) agreement with the client after verification of the safety file and thereafter be issued with a permit to commence work if the safety file has been checked and approved by the client.
- **Failure to provide the safety file will result in withdrawal of the award letter and purchase order.**
